This completed contract and deposit are what will reserve your chosen date and time. A deposit of \$_____ (50% of the estimated total) must be paid within 30 days after the trial, or at least 30 days before the event date (whichever is sooner). This deposit is refundable only up to 30 days before the event date. If cancelled with less than 30 days' notice, the deposit is non-refundable.

Please make sure that there is an area cleared for the staff to set up and use. This includes a flat surface for set up, a nearby outlet and a chair (bar stool height preferred, most hotels can accommodate if asked ahead of time) for each stylist. We kindly request this to be in a well-lit area (natural light if available) that is clear of a lot of foot traffic. Please advise **ALL guests receiving services to arrive 15 minutes before the deiced start time**, and to come with clean (washed the day before), dry hair and a clean face if getting their make-up done. We also recommend that everyone receiving services wear a button-down shirt or a robe.

A credit card is required to hold all reservations. No charges will be made to your card until due dates as listed previously. This card will be the method of payment for everything unless otherwise noted before due dates/day of event. A 20% Gratuity will be added to all services, before travel fees. Bride(s) assumes responsibility of all costs for her party's services. If the reservation is cancelled before 30 days of event, only the \$100 is retained. After 30 days, the 50% is also retained. If cancelled with less than 14 days' notice, the full estimated amount will be applied to the card. Please call the salon during business hours to have your card put on file.

The remainder of the services fees will be applied to the card on file the day of the event within 4 hours of completion. If another form of payment is preferred you may add 1 additional card to your file by contacting the salon at least 14 days before the wedding, or by paying with 1 check to the head stylist after services are complete and a total can be calculated.
